#### **Precautionary Statements - Response**

IF INHALED: Remove person to fresh air and keep comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water (or shower).

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

In case of fire: Use CO<sub>2</sub>, foam, dry chemical, water fog to extinguish.

#### **Precautionary Statements - Storage**

Store locked up. Store in a well ventilated place. Keep container tightly closed. Keep cool.

#### 4. FIRST AID MEASURES

# Most important symptoms and effects, both acute and delayed

Contact with eyes may cause irritation or discomfort. Inhalation of mist/vapors/spray may cause respiratory tract irritation leading to a temporary burning sensation of the nose and throat, coughing, and difficulty breathing. Ingestion may cause irritation or a burning sensation of the mouth and throat and abdominal pain.

#### Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

# 5. FIRE-FIGHTING MEASURES

#### Suitable Extinguishing Media

CO<sub>2</sub>, foam, dry chemical, water fog.

#### Unsuitable Extinguishing Media

Do not use a solid water stream as this may spread the fire.

#### Specific hazards arising from the chemical
