### Precautionary Statements - Prevention

Keep only in original container.

### Precautionary Statements - Response

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor/physician.  
IF ON SKIN (or hair): Take off Immediately all contaminated clothing. Rinse SKIN with water/shower. Wash contaminated clothing before reuse. Immediately call a POISON CENTER or doctor/physician.  
IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor/physician.  
IF IN EYES: rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do so. Continue rinsing. Immediately call a POISON CENTER or physician.  
Absorb spillage to prevent material damage.

**4. FIRST AID MEASURES**

<b>Ingestion:</b>	Do not induce vomiting unless directed by medical personnel. Rinse mouth with water and drink 1 or 2 glasses of water and call a POISON CENTER or doctor/physician immediately. Do not give anything by mouth to an unconscious person.
<b>Skin contact:</b>	Take off contaminated clothing and rinse skin with plenty of water. Get medical advice/attention. Wash any contaminated clothing before re-use.
<b>Inhalation:</b>	If difficulties occur after mist/vapors/spray has been inhaled, remove person to fresh air and keep comfortable for breathing. Call a POISON CENTER or doctor/physician.
<b>Eye contact:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a POISON CENTER or doctor/physician immediately.

**Most important symptoms and effects, both acute and delayed.**

Contact with eyes may cause serious irritation leading to discomfort or pain, redness, swelling, and blurred vision. Contact with skin may cause severe burns or irritation with local redness. Ingestion can lead to severe burns of the mouth and throat, as well as perforation of internal organs.

**Indication of any immediate medical attention and special treatment needed.**

Treat symptomatically.
