Hazard Statements

4. FIRST AID MEASURES

Most important symptoms and effects, both acute and delayed.

Contact with eyes may cause serious damage or irritation leading to discomfort, redness, swelling or blindness. Contact with skin may cause irritation with local redness and possible dermatitis shortly after exposure. Inhalation of vapors may cause drowsiness or dizziness, headaches, fatigue, muscular weakness and in extreme cases, loss of consciousness.
