Equipment to be treated	Agricultural and horticultural equipment and surfaces such as ceilings, walls, floors and water distribution system.
Use procedure	Manually remove a maximum of soil. Clean with an adequate detergent solution then rinse with potable water. Spray, soak, circulate (C.I.P.) or flood HYPER SAN . Sanitize with of 6 ml HYPER SAN dissolved in 4 litres of water (0.16% v/v concentration, or 98 ppm active peroxyacetic acid). All surfaces should be exposed to sanitizing solution for a period of at least 60 seconds. Drain thoroughly and allow to air dry. Do not rinse. Use dilutions up to 13 ml of this product per 4 litres of water (197 ppm peroxyacetic acid) may be used.
