**Precautionary Statements - Response**

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

**4. FIRST AID MEASURES****Eye contact**

**Skin contact**

If difficulties occur after mist/vapors/spray has been inhaled, remove person to fresh air and keep comfortable for breathing. Call a POISON CENTER or doctor/physician.

**Ingestion**

Immediately call a POISON CENTER or doctor/physician. Rinse mouth.

**Most important symptoms and effects, both acute and delayed**

Contact with eyes may cause irritation, discomfort or pain, excess blinking and tear production with marked excess redness and swelling of the conjunctiva. Contact with skin may cause irritation with local redness. Prolonged contact with skin may be harmful. Inhalation of mist/vapors/spray may be harmful and cause irritation of the mucous membranes and upper respiratory tract leading to a burning sensation of the nose and throat, coughing, and difficulty breathing. Ingestion may be harmful and cause blindness. Exposure may cause irritation or a burning sensation of the mouth and throat and abdominal pain.

**Indication of any immediate medical attention and special treatment needed**

## 6. ACCIDENTAL RELEASE MEASURES

### Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Do not breathe vapor or mist. Wear appropriate respirator when ventilation is inadequate. Put on personal protective equipment. Remove all sources of ignition. Evacuate personnel to safe areas.

### Environmental Precautions

Avoid discharge into drains/surface waters/groundwater. Prevent further leakage or spillage if safe to do so.

### Methods and material for containment and cleaning up

Contain and solidify with inert absorbent material. Keep in suitable, closed containers for disposal. Following product recovery, flush the area with water. For large spills, stop flow of material, prevent product from entering drains, and pump off product where this is without risk and possible. Proceed as above.

## 7. HANDLING AND STORAGE

### Precautions for Safe Handling

#### Handling

Avoid contact and inhalation of mist/vapors/spray. Avoid contact with skin, eyes and clothing. Ensure thorough ventilation of work areas. Use personal protective equipment. Smoking, eating and drinking should be prohibited in the application area.

### Conditions for safe storage, including any incompatibilities

#### Storage

Keep containers tightly closed away from direct sunlight in a dry, cool and well-ventilated place, away from incompatible materials.
