Most important symptoms and effects, both acute and delayed

Contact with eyes may cause serious irritation leading to discomfort or pain, excess blinking and tear production with marked excess redness and swelling of the conjunctiva, blurred vision, and possible corneal injury. Contact with skin may cause irritation with local redness. Inhalation of mist/vapors/spray may cause drowsiness or dizziness as well destruction of the mucous membranes and upper respiratory tract leading to a burning sensation of the nose and throat, coughing, and difficulty breathing. Ingestion may cause irritation or a burning sensation of the mouth and throat and abdominal pain accompanied by nausea or vomiting. Aspiration into the respiratory system during ingestion or from vomiting may cause mild to severe pulmonary injury and possibly death.
