## **Volatile Organic Compound Concentration Limits for Certain Products Regulations**

As the calendar turns to 2024, we're taking steps at West Penetone to adapt to new regulations coming into effect from the Department of Environment and Climate Change Canada (ECCC). These regulations provide new rules governing the manufacture of certain products in Canada containing volatile organic compounds (VOC), including those in the following categories of use:

Product Category
Automotive brake cleaner
Automotive wash
Automotive wax
Electrical equipment cleaner
Engine degreaser
General purpose degreaser
General purpose hard surface cleaner and disinfectant
Multipurpose solvent to remove organics
Products to remove road grime including tar and asphalt

The goal of this communication is to create awareness of these regulatory changes from ECCC, and help customers and end users of West Penetone products understand how these changes may or may not affect their operations.

It's crucial to clarify that these new rules primarily impact our manufacturing and record-keeping processes, and typically no special actions are expected to be required on the part of our customers and end-users.
